## Navigating Uncertainty:

### What the 2025 Canadian Election Means for Jewish Canadians

The results of the 2025 Canadian federal election sent ripples through many communities—none more than Canada's Jewish population. With Mark Carney now serving as Prime Minister, while there's hope for improvement, concern and a sense of urgency dominate the dialogue. As Jewish Canadians watch political priorities shift, many are left wondering: **Where do we go from here?**

### Antisemitism Is Rising—and It's Personal

Let's be honest—antisemitism in Canada isn't just a statistic. It's a daily reality that so many of us are seeing, feeling, and fearing.

B'nai Brith Canada's 2024 audit reported a 7.4% increase in antisemitic incidents over the previous year, from hateful graffiti to threats, harassment, and worse. It's disturbing—and it's getting harder to ignore.

Just today, B'nai Brith called on Prime Minister Carney to make the safety of Jewish Canadians, and other vulnerable communities, a national priority. The question is: Will he respond?

Frankly, many in our community are tired. Tired of inaction. Tired of empty promises. Tired of watching our concerns brushed aside. As a Jewish Canadian, I find it heartbreaking that we still have to fight this hard just to feel safe in our own country.

### The Jewish Vote Is Shifting

Historically, Jewish Canadians have voted across the political spectrum. But this election revealed deep divisions—and a major shift. Many moved away from the Liberals, frustrated by how they've handled antisemitism and Israel policy. The Conservatives picked up support by promising stronger action on hate crimes and a clearer alliance with Israel.

Still, some voters stuck with the Liberals, drawn by Carney's economic expertise and wary of hardline rhetoric echoing from U.S. politics. There's no single answer here—but what's clear is that the Jewish vote is no longer guaranteed for any party.

### Where Does Canada Really Stand on Israel?

For many of us, Canada's stance on Israel is more than politics—it's personal. Over the past few years, the Liberal government has taken positions that have frustrated and alienated pro-Israel Canadians: from backing UN resolutions critical of Israel to halting arms sales.

And let's not ignore the tension around Canada's intake of Gazans and how it may be fueling antisemitic sentiment. These choices have consequences—not just for foreign policy, but for how safe and supported we feel here at home.

Prime Minister Carney says he's committed to protecting Jewish Canadians. We hope that's true. But his track record on Israel leaves many of us skeptical.

### What Now?

We're at a crossroads. As antisemitism rises and the political landscape shifts, we can't afford to be passive. Now's the time to speak up, get involved, and protect what matters most—our families, our values, and our future. Whether that means staying and advocating or exploring options elsewhere, you don't have to walk this path alone.

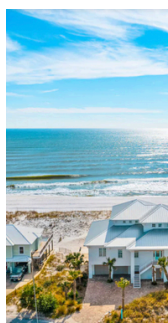

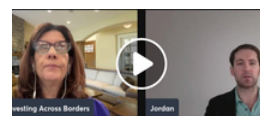

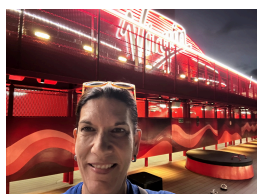
