

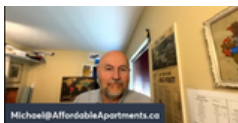

Canadian Concerns: Is It Time to Relocate?

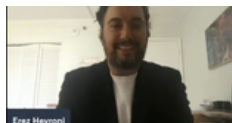

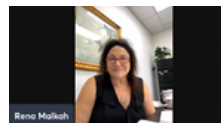

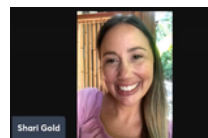

Is It Time to Leave Canada?

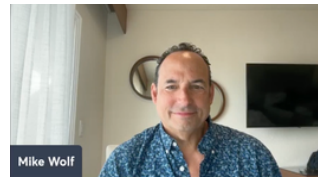

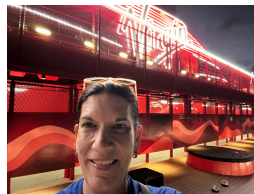


U.S. Snowbird Update: Major POTENTIAL News for Canadians!

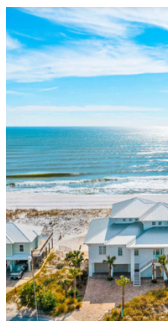

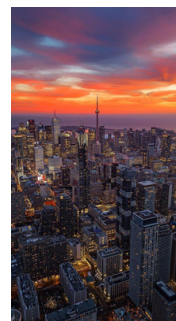

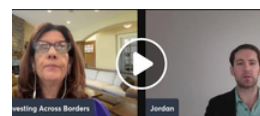
